6 CHARTER RESOLUTION 15-CR-02

8 Charter Resolution of the Mayor and Common Council of University Park, pursuant to the
9 authority of Article XI-E of the Constitution of Maryland and §4-301 *et seq.* of Local Government
10 Article, Annotated Code of Maryland, as amended, to amend the Charter of the Town of
11 University Park, by repealing and re-enacting Article VI, "Finance", Section 618, "Purchasing and
12 Contracts" of the Charter to add the Town Newsletter Editor as a professional service position to
13 be appointed by the Mayor and approved by the Council.

14 Section 1: Be it resolved and ordained by the Mayor and Common Council of University
15 Park that Article III, "Mayor and Common Council", Section 311, "Enactment of Ordinances" of
16 the Charter of the Town of University Park be repealed and re-enacted as follows:

17 Section 618. Purchasing and Contracts

18
19 (a) Purchases for the Town government shall be made by the Treasurer under the direction of the
20 Mayor and Common Council. The Common Council may establish by Ordinance, rules and
21 regulations regarding purchasing procedures including the use of competitive bids.

22 (b) All contracts involving professional services such as accounting, architecture, auditing, engineering,
23 law, planning, TOWN NEWSLETTER EDITOR and surveying shall be negotiated by the Mayor and
24 approved by the Common Council. THE NEWSLETTER EDITOR SHALL SERVE AT THE PLEASURE
25 OF THE MAYOR AND COUNCIL.

26 Section 2: Be it further resolved that this resolution shall become effective fifty days after


1 enactment by the Mayor and Common Council of University Park, Maryland, unless petitioned to
2 referendum in a manner prescribed by law.


3 Section 3: Be it further resolved that a complete and exact copy of this proposed Charter
4 amendment shall be posted on the entrance door of the Town Hall of University Park, 6724
5 Baltimore Avenue, University Park, Maryland, for a period of not less than forty (40) days, and a
6 fair summary of this Charter amendment shall be published at least four times on four successive
7 weeks within that forty day period in a newspaper having general circulation in the community.
